- 1. Need based One Day Training Programme at NGOs premises need to be organized with the support from KVK- Ms.Radha, MOTHER NGO, Sira.
- 2. Arka Microbial Consortium (AMC) should be made available in large quantity for organic farmers, as the demand for AMC is more Mr.Anandakumar, Aviskar NGO, Tumakuru
- 3. Need to cover more success stories of farmers, apart from regular programmes, with the support from KVK Ms. Rashmi, FM Radio Siddhartha, Tumakuru.
- Malnutrition is problem seen at 10 Taluks of Tumakuru. In this regard one day training on Kitchen gardening to farm women groups and staff of department in necessary – Ms. Vasanthi Uppar, Women and Child Welfare Department, Tumakuru
- Need to have an OFT by SMS (Home Science) in this field of women & child care Dr.Srinath Dixit, ATARI, Bengaluru
- Healthy products like Mushroom powder can be obtained from IIHR and distributed to rural women – Dr.Krishna Reddy, Director, IIHR, Bengaluru.
- An exposure visit to IIHR for Vegetable & Fruits Farmers for Value addition and Post Harvest Technology - Dr.Srinath Dixit, ATARI, Bengaluru

- PoP Technologies related to Organic farming, Polyhouse, Dryland horticulture is need of the hour and need to be provided by KVK– Mr.Harshs, H.O, Dept. Of Horticulture, Tumakuru
- IIHR technologies are available related to Hitech horticulture under poly house in website. Farmers can get exposure through KVK - Dr. Balakrishna, Nodal Officer, KVK, Hirehalli.
- 10. Use of Mucuna in horticulture will help in soil conservation, mulching and water conservation Dr. Vasanthkumar, PI, COE on Betelvine, Hirehalli
- 11. Farmers practicing installation of Net in the farm for protection of fruit crop like Pomegranate. This leads to death of many birds. Need to be addressed. Plastic Mulch in the field might be a menace in future. Safe disposal / Recycling are necessary, Disposal part need to be included during the training programmes – Mr. Nagendra, ACF, Department of Forestry, Tumakuru.
- 12. Plastic mulch of 80 micron or 100 micron can be recycled after two to three crops. Dr.Balakrishna, Nodal Officer, KVK, Hirehalli.
- 13. Birds scare technology (Sound Technology) from IIHR is available. This can be utilized. -Dr. Krishna Reddy Director,
- 14. Bird reflectors from private company is available at Rs. 6000/- per piece. This needs to evaluated further Organic farmer Sri Prabhakar, Tumakuru.
- 15. NABARD Farmers clubs from KVK need to be developed. Grant support of Rs.10000/will be given – Mr.J.S.Veerabhadran, DDM, NABARD, Tumakuru.
- 16. Millet Mela is required for profit making business to farmers involved in Millet cultivation Mr.J.S.Veerabhadran, DDM, NABARD, Tumakuru.
- 17. NGOs Tribal Development Projects Coconuts and 100 tonnes of Mangoes (NISARGA brand) are available, for which Market linkage is required, Training on PoP on Moringa is needed Ms.Radha, MOTHER NGO, Sira.
- 18. Direct selling in the premises of IT companies at Bengaluru shall be explored, Dr.Hebbar of IIHR can be contacted for Organic Moringa cultivation - Dr.Balakrishna, Nodal Officer, KVK, Hirehalli.

- 19. Mango Campaign (Ripening Chambers, Fruit Fly Traps, Mango Special complete package) will be organized in collaboration by KVK in the farmers' fields of Sira supported by ORDER NGO – N.Loganandhan, Head, KVK, Hirehalli
- 20. GKVK 5 (Groundnut variety with Medium Size, 8-9 Quintal per acre), Cashew and Tamarind- GKVK -17 shall be tried in new clusters– Dr.Prabu Ganigar, ARS Pavagada.
- Sericulture Pruning technique with Battery operated secateurs for demonstration- Mr.
  M.V.Chandru, Dept. of Sericulture
- 22. Details of importers will be given Dr.Balakrishna, Nodal Officer, KVK, Hirehalli.
- 23. Market linkage for minor millets is very much required Dr.Roopa Devi, JDA, Tumakuru.
- Minor millets of any quantity can be supplied to Ravishankar Guruji Ashram Dr.Srinath Dixit, ATARI, Bengaluru
- 25. Non-pesticide Management of crops and practices is necessary Mr.Anandakumar, Avishkar NGO, Tumakuru.
- 26. Senior officers like Mr.Ramakrishnappa and Mr.Gurudutt of Horticulture Department, Bengaluru, shall be contacted to market the products through JKS group -Dr.Balakrishna, Nodal Officer, KVK, Hirehalli.
- 27. KVK products need to be kept at RSK of Agriculture dept to reach to farmers. Information of Drumstick as fodder crop inform is required- Mr. Prabhakar, SAC Member, Tumakuru.
- 28. Technology for drying of vegetable, fruits and medicinal plants (e.g.Tulasi) need to be addressed Mr.Mahesh, SAC Member, Tumakuru.
- 29. KVKs of Tumakuru can be recognized as Model KVKs of Zone VIII with Horticulture and Agriculture emphasis, Chintamani variety of Jamoon can be used for dry land horticulture Dr.Jagadeeswara.K., DE, UAS, Bengaluru
- 30. Support of NBSS&LUP for Sujala III phase watershed programmes and Maps of fertility can be obtained by KVK Dr.Rajendra Hegde, Head, NBSS&LUP, Bengaluru.
